





# Exporting to Africa



### ALGERIA CERTIFICATE OF CONFORMITY (COC)

The Algerian Ministry of Commerce requires all importers to oblige with their national conformity standards and submit a proof of conformity for their imported goods. The obligation is enforced by law on conditions and procedures of conformity control of imported goods at customs. As an authorized certification and inspection body, TÜV Rheinland performs a conformity and compliance check and accordingly issues the required 'Certificat de Contrôle Qualité' in the country of export.

#### Regulated Product Categories

All consignments of imported goods and for which the payment method is Letter of Credit (L/C) or Cash Against Documents (CAD) are subject to the Algerian CoC program.

### BOTSWANA CERTIFICATE OF CONFORMITY (COC)

Botswana Bureau of Standards (BOBS) implemented the [Standards Import Inspections Regulations \(SIIR\)](#) to control the quality of prescribed imports as listed in regulations. TÜV Rheinland is an authorized inspection body for the Botswana SIIR Scheme to issue Certificates of Conformity (CoC) that allow traders to gain market access to Botswana.

### ATTESTATION OF CONFORMITY (AOC)

To safeguard the end consumer and monitor the quality of imported products, the Pre-Shipment Evaluation of Conformity program (PECAE: Programme D'évaluation de la Conformité Avant Embarquement) has been implemented by L'Agence des Normes et de la Qualité (ANOR) in Cameroon. The objective of the PECAE scheme is to protect Cameroonian consumers and the environment from low-quality, hazardous, and counterfeit goods entering Cameroon.

Upon the issuance of the AoC, the Certificate of Conformity (CoC) will be granted by ANOR through GUCE. GUCE, or the Single Window for Foreign Trade (Guichet Unique des Opérations du Commerce Extérieur), is a platform established by the State of Cameroon.

#### Regulated Product Categories:

All products are regulated and must obtain their AoC from TÜV Rheinland, except for the ones categorized as Exempted/Prohibited.

### ETHIOPIA CERTIFICATE OF CONFORMITY (COC)

In Ethiopia, the Pre-Shipment Verification of Conformity (PVoC) program is a mandatory compliance program overseen by the Ethiopian Conformity Assessment Enterprise (ECAE) under the Ministry of Trade and Regional Integration (MOTRI). The scheme ensures that goods are inspected and certified prior to shipment, with the primary aim of protecting Ethiopian consumers and the environment from substandard, unsafe, or counterfeit imports.

Upon successful evaluation, a Certificate of Conformity (CoC) is issued, which is required for customs clearance in Ethiopia. This process streamlines market access while safeguarding compliance with national quality and safety standards.

## Kenya



### KENYA CERTIFICATE OF CONFORMITY (COC)

Kenya's Pre-Export Verification of Conformity (PVOC) program, administered by the Kenya Bureau of Standards (KEBS), requires regulated goods to be inspected and certified prior to shipment. A Certificate of Conformity (CoC) is issued upon successful verification and is mandatory for customs clearance, confirming compliance with Kenya's national standards.

**Below are the regulated products. Those classified as exempted, prohibited, or restricted are excluded from the PVOC requirement.**

\* Used vehicles, used spare parts, and mobile equipment are covered by a different inspection agency under the Kenya PVOC Program

\*\* Second-hand textiles and footwear must comply with a protocol established by KEBS. A key requirement of this protocol is the assessment of baling and sorting facilities in the country of export to ensure compliance with the applicable standards.

**Note:** Certain high-risk shipments destined for Kenya—such as food products, cosmetics, toys, electrical and electronic items, as well as fertilizers and soil conditioners— may require a Free Sale Certificate (FSC) issued by the country of export or origin. A Free Sale Certificate issued by an authorized agency demonstrating that the product is freely sold and compliant with the applicable regulatory requirements in the country of origin/export. ## Libya



### LIBYA CERTIFICATE OF INSPECTION (COI)

The Central Bank of Libya issued Resolution N° 96 that establishes the requirement of a Certificate of Inspection (CoI) for all goods imported into Libya. Therefore, as per legal requirements, all exporters need an inspection certificate before exporting to Libya. Under the Libyan Scheme, products to be imported shall undergo an inspection in the country of export and the CoI is accordingly issued by TÜV Rheinland upon a positive result. Partnering with us means short lead times and established working relations with several local partners.

All goods imported into Libya require a CoI issued by a local or international inspection company, which must have a code in the Central Bank of Libya to allow these shipments to be financed through a documentary Letter of Credit (L/C) issued by a commercial bank.

## Morocco



### MOROCCO CERTIFICATION OF CONFORMITY (COC)

The Ministry of Commerce and Industry (MCI) implemented a [Verification of Conformity \(VOC\) program](#) in 2020 for a defined scope of products entering the Kingdom of Morocco.

The VOC program requires that consignments falling under the list of regulated products are accompanied by a Certificate of Conformity (CoC) to prove compliance with national quality and safety regulations.

TÜV Rheinland is an authorized inspection body to issue the Certificate of Conformity from the country of export and to execute Destination Inspections (DI) at Morocco border points.

## Sudan



### SUDAN CERTIFICATE OF INSPECTION (COI)

To safeguard the well-being of consumers in Sudan, the Sudanese Standards and Metrology Organization (SSMO) has launched the Pre-Shipment Verification Program, requiring regulated products exported to Sudan to hold a Certificate of Inspection (CoI) to demonstrate compliance with national and international standards, ensuring a smooth clearance process with Sudanese Customs.

As an authorized international surveyor by SSMO, TÜV Rheinland can carry out a range of inspection, testing, analysis, and conformity assessment services that conclude with the issuance of the Certificates of Inspection (CoI) for regulated goods exported to Sudan that are complying with national and international standards and regulations applicable in the country. Additionally, TÜV Rheinland works closely with exporters and importers targeting the Sudanese market, helping them achieve their goals in accessing new markets while adhering to international standards and regulations and supporting SSMO in their journey to ensure that products entering Sudan are in line with the desired standard.

### TANZANIA CERTIFICATE OF CONFORMITY (COC)

In order to protect the consumers in Tanzania from substandard products, the Tanzania Bureau of Standards (TBS) governs the [Pre-Shipment Verification of Conformity \(PVoC\) program](#), provided for by Section 4(1)(s) of the Standards Act No. 2 of 2009. As part of the PVoC, TÜV Rheinland experts will conduct conformity assessments on regulated products to verify compliance with the TBS regulations. Following a successful assessment, the Certificate of Conformity will be issued, allowing exporters and importers to gain a seamless entry for their goods into the Tanzanian market.

The primary means of economic development has been industrialization. For some economies, this has meant producing consumer goods like electronics, footwear, or clothing as subcontractors for foreign firms.

## Indonesia



### INDONESIA CERTIFICATE OF INSPECTION (COI)

The Ministry of Trade issued a regulation establishing the requirement of [Technical Verification and Tracing \(VPTI\)](#) for various product categories imported into Indonesia. It ensures that each consignment of goods complies with relevant national and international standards as well as technical regulations. TÜV Rheinland is authorized as an approved vendor in conducting shipment inspection and document review on behalf of Anindya Wiraputra Konsult, a certification body appointed by Indonesia's trade department.

## Philippines



### PHILIPPINES LOAD PORT SURVEY (LPSR) AND SUMMARY (SR) REPORTS

To ensure swift and speedy global trade, TÜV Rheinland has been authorized by the Committee for Accreditation of Cargo Surveying Companies (CACSC) in the Philippines for the [Bulk and Break Bulk Cargo Clearance Enhancement Program](#). This program is a pre-shipment inspection process to ensure that imported products meet national and international standards.

#### Regulated Product Categories

- Cargoes in a mass of one commodity not packaged, bundled, bottled or otherwise packed
- Cargoes (dry or liquid) which are loaded (shoveled, scooped, forked, mechanically conveyed or pumped) in volume directly into a vessel's hold
- Cargo, unbound when loaded, without count in a loose unpackaged form
- Non-containerized general cargo stored in boxes, bales, pallets or other individual units to be loaded onto or discharged from vessels
- Cargo loaded individually and described in terms of quantity and weight, (e.g., steel coils, logs, sacks of rice) and not in shipping containers nor in bulk as with oil or grain
- Liquids, chemicals, petroleum products, and all other cargo shipped in bulk and break bulk, the duties and taxes of which are normally determined by weight (e.g., wood, steel, coal, grains, etc.)

# Exporting to the Middle East

The Middle East is a geopolitical region that includes the Arabian Peninsula (GCC countries and Yemen), Turkey, Egypt, Iran, the Levant, and Iraq. This term was widely used to replace the Near East beginning in the early twentieth century (as opposed to the Far East).

The Middle Eastern economy is strategically diverse and best known for its oil production and export, which has a significant economic and labor impact across the region. In recent years, many of the countries in the region have made efforts to diversify their economies.

Top three exported products in the region are fuels, raw materials, and consumer goods while the top three imported products are consumer goods, capital goods, and intermediate goods.

### EGYPT CERTIFICATE OF INSPECTION (COI)

General Organization for Export and Import Control (GOEIC) has implemented a 'Verification of Conformity' (VOC) program for Egypt. Exporters of regulated products are to provide proof of company registration with GOEIC and of shipment conformity with VoC regulations before their goods may enter Egypt.


TÜV Rheinland is an inspection body accredited for the Egyptian GOEIC Scheme and authorized to issue the required 'Certificates of Inspection (CoI)'.

### IRAQ CERTIFICATE OF CONFORMITY (COC)

The ICIPI Program is an important regulatory framework for goods imported into Iraq. It ensures that imported products meet the necessary quality and safety standards before they enter the Iraqi market.

TUV Rheinland is appointed by the Central Organization for Standardization and Quality Control (COSQC) as a notified body for the ICIPI program (Pre-Inspection, testing and certification Program) for Goods entering the Republic of Iraq.

As an authorized certification body, TUV Rheinland will carry out the conformity assessment procedures for all regulated products with applicable Iraqi standards and technical regulations.

Our main objective is to prevent non-compliant products and guarantee adherence to the Iraqi regulations, safeguard consumer interests and strengthen market trust, manage risks by assuring safety and quality, avoid hazardous products, reduce waste, and so protect the environment, streamline customs clearance procedures with an efficient practice for the issuance of the Certificate of Conformity (COC), and encourage equitable trade practices and support its facilitation.

Based on their nature, application, safety, and performance, regulated products are classified as low, medium or high risk products.

As a certification body accredited for all the technical regulations under SALEEM Scheme, TÜV Rheinland is authorized to issue the required Product and Shipment Certificates of Conformity (CoC) as well as the [Saudi Quality Mark \(SQM\)](#). In addition, TÜV Rheinland is authorized by [Saudi Food and Drug Authority \(SFDA\)](#) to issue the CoCs for cosmetics and food products.

We can also handle the application for other labels and certificates like WEL, EER, and Saudi IECEE Recognition Certificate. Required testing for e.g. the SIRC, CB, IEC, and EMC schemes may also be performed by our global network of accredited laboratories.

The Ministry of Public Health - Food Safety Department (MoPH-FSD) has appointed TÜV Rheinland as a Third Party Inspection and Certification body authorized to carry out the Pre-Shipment Inspection and Verification process for food product consignments exported to the State of Qatar.
