Dodd-Frank Section 1502 and the SEC ruling on Conflict Minerals addresses concerns that conflict minerals finance armed groups committing human rights violations in several African countries. The rule describes due diligence and reporting requirements for companies whose products contain conflict minerals (tin, tantalum, tungsten and gold) that originate in the Democratic Republic of Congo (DRC) or the nine adjoining countries (covered countries). In response to this ruling, **TÜV Rheinland,** can help companies manage their compliance efforts. Companies must comply with the disclosure requirements by May 31, 2014 and the industries most likely to be affected include jewelry, electronics and technology, and automotive.
